**AN ORDINANCE**  
**AUTHORIZING THE MAYOR TO ENTER INTO AN AGREEMENT WITH SHELLY MATERIALS, INC. DBA MEDINA SUPPLY CO. FOR THE FURNISHING OF READY MIX CONCRETE, AND DECLARING AN EMERGENCY.**

**BE IT ORDAINED** by the Council of the City of Bay Village, Ohio:

**SECTION 1.** That the Mayor is hereby authorized to enter into an agreement with Shelly Materials, Inc. DBA Medina Supply Co., 230 East Smith Road, Medina, OH 44256, for the furnishing of ready mix concrete for various streets within the City of Bay Village for the period of one year. The prices are as follows:

MS Mix (per yard)		\$130.00 Cu Yard
Added cost for residential fiber (1 lb. per yard)		\$5.50 Yard

Liquid Calcium Chloride 1 percent (1%) per yard		\$2.00 Cu Yard
Liquid Calcium Chloride 2 percent (2%) per yard		\$4.00 Cu Yard

Additional costs for multiple stops and/or demurrage time: no charge per additional stop;  
\$1.50 per minute demurrage time after 30 minute for 1-5 yards;  
\$1.50 per minute demurrage time after 60 minute for 5.25-10 yards.

Normal delivery hours: 7:00 A.M. to 3:00 P.M.

Additional cost for delivery other than regular business hours: \$50.00 per load


Additional cost for delivery on Saturday: \$75.00/load

The bid of said Company being hereby determined to be the lowest and best bid received after advertising according to law. The agreement shall be in a form approved by the Director of Law, and the Director of Finance is hereby authorized and directed to pay said contract price from funds appropriated for the purpose.

**SECTION 2.** That this Council finds and determines that all formal actions of this Council concerning and relating to the passage of this ordinance were taken in an open meeting of this Council, and that all deliberations of this Council and of any committee that resulted in those formal actions were in meetings open to the public in compliance with law.


**SECTION 3.** That this ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health, safety and welfare, and for the further reason that it is immediately necessary to provide ready mix concrete for road surface treatments, wherefore this ordinance shall be in full force and take effect immediately upon its passage and approval by the Mayor.
