## A RESOLUTION

AUTHORIZING THE OHIO DEPARTMENT OF TRANSPORTATION TO RECONFIGURE THE CAHOON WOLF INTERSECTION WITHIN THE CITY OF BAY VILLAGE, AND DECLARING AN EMERGENCY.

WHEREAS, on the 17th day of October, 2022, the LPA enacted legislation proposing cooperation with the Director of Transportation for the described project:

The project consists of reconfiguring the Wolf Road and Cahoon Road intersection by removing the west bound right turn lane; replacing curb ramps and crosswalks; asphalt resurfacing; and new pavement marking along Wolf Road, lying within the City of Bay Village; and

WHEREAS, the LPA shall cooperate with the Director of Transportation in the above described project as follows:

The City agrees to assume and bear one hundred percent (100%) of the entire cost of the improvement within the city limits, less the amount of Federal-Aid funds set aside by the Director of Transportation for the financing of this improvement from funds allocated by the Federal Highway Administration, U. S. Department of Transportation.

The share of the cost of the LPA is now estimated in the amount of One Hundred Eighty-Four Thousand, Five Hundred Eighty and 00/100 Dollars, (\$184,580.00), but said estimated amount is to be adjusted in order that the LPA's ultimate share of said improvement shall correspond with said percentages of actual costs when said actual costs are determined; and

WHEREAS, The Director of Transportation has approved said legislation proposing cooperation and has caused to be made plans and specifications and an estimate of cost and expense for improving the above described highway and has transmitted copies of the same to this legislative authority; and

WHEREAS, The LPA desires the Director of Transportation to proceed with the aforesaid highway improvement.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Bay Village, Ohio;

SECTION 1. That the estimated sum, of One Hundred Eighty-Four Thousand, Five Hundred Eighty and 00/100 Dollars, (\$184,580.00) is hereby appropriated for the improvement described above and the fiscal officer is hereby authorized and directed to issue an order on the treasurer for said sum upon the requisition of the Director of Transportation to pay the cost and expense of said improvement. We hereby agree to assume in the first instance, the share of the cost and expense over and above the amount to be paid from Federal funds.

Resolution – Final - ODOT Cahoon Wolf Intersection

**SECTION 2.** That the LPA hereby requests the Director of Transportation to proceed with the aforesaid highway improvement.

SECTION 3. That the LPA enter into a contract with the State, and that the Mayor be, and is hereby authorized to execute said contract, providing for the payment of the LPA the sum of money set forth herein above for improving the described project.

**SECTION 4.** That the LPA transmit to the Director of Transportation a fully executed copy of this Resolution.

SECTION 5. That this Council finds and determines that all formal actions of this Council concerning and relating to the passage of this resolution were taken in an open meeting of this Council, and that all deliberations of this Council and of any committee that resulted in those formal actions were in meetings open to the public in compliance with law.

**SECTION 6.** That this resolution is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health, safety and welfare, and for the further reason that it is necessary to authorize the filing of said application in a timely manner, wherefore this resolution shall be in full force and take effect immediately upon its passage and approval by the Mayor.
